## *Exchange Program Guidelines and Regulations*

**These regulations have been devised to ensure a successful educational experience for *all* participants.**

### **Being Part of a Group**

Successful group travel is dependent upon considerate, unselfish behavior by all members of the group. No PDA!

### **Punctuality**

Tempers soon fray if the group is kept waiting for a few people who are always late for sightseeing tours, meals and other activities. Every day, your teacher will outline planned activities. We request that participants take careful note of the schedule and *always* be on time. This is particularly important for all travels by public transportation. (They don't wait!).

### **Neatness**

We request that all participants keep themselves and their belongings clean and orderly. Be considerate—don't leave your room, train, or sightseeing bus in disarray. Offer to help and don't expect your host family to serve you. You are a "family member" and not only a guest.

### **Listening**

Listen carefully to all instructions you receive from your accompanying teachers, host families, or teachers in host schools. Give schedule of events (especially changes) to your host family, so that they are informed of our trips.

### **Curfew**

There is no pre-set curfew while staying with your host families. However, since some of our big daily tours might start as early as 5:30 am, it is essential that you are well rested. Upon return, your host family will expect you to return to your host home immediately. ***Your host family will expect that you spend time with them in return for their hospitality.*** Remember, this is *not* a vacation but an educational experience! Students are *never* permitted to go out unaccompanied by an adult or their host student.

When we are traveling on our own, no one is permitted to leave the hotel or restaurant, and no one is allowed to leave the rooms after curfew.

1. All scheduled program activities are obligatory. If you are sick, and therefore unable to attend, you must inform the Exchange Program Coordinators immediately (Tel. 333-8953427).
2. You are not allowed to leave town by yourself. If your host family wants to take you sightseeing on the weekend, this is of course encouraged. When on our trip, students may split up into groups; however, given the current situation, students always need to be accompanied by an adult.
3. Visitors or group members of the opposite sex are not to be in your room. Spend most of the time with your assignments and host family. American students are not to make plans of their own and are not to meet with other American students during the home stay unless the Italian family arranges this.
4. Smoking is not permitted!
5. Hitchhiking and driving and renting of any motor vehicle are strictly forbidden for all students. I understand that some students will have a license (age 18 and above) and will drive students.
6. ***Alcohol consumption is NOT permitted. Any participant, of any age, is subject to disciplinary action including dismissal from the program at the students' or parents' own expense.***
7. Shoplifting and possession of illegal drugs are extremely dangerous abroad. Automatic dismissal from the program will result, and the participant shall return home at his or her own expense. Should authorities be involved, participants will be subject to the laws of the country they are visiting.
8. Neither the teachers nor the host families are liable for any kind of problems that may occur during the trip. Students cannot be supervised 24 hours a day!
9. Students/parents agree that breathalyzers and/or drug tests can be administered at any time if there should be doubt of a participant having abused any substance.
10. Students and parents have read and agree to the Exchange Program Rules and Regulations and have signed the Hamp.Co. BOE waiver.
11. No active cell phones, Ipads (as cameras) and/or laptops are permitted.

## General Requirements

### Fundraisers and Payments

1. Successful participation at all fundraisers
2. On time payments as indicated on schedule (noncompliance might cause dismissal from program)

### Documents and other Obligations by August 31, 2020

3. Passport acquisition (if applicable) or documentation that processing has occurred
4. Two (2) ATM cards from FNB (works best) with 4 digit passcodes
5. ID or permit as second legal identification

### Luggage requirements

6. 1 (one) suitcase measuring 24/25 x 16 x 10 (H x W x D max); max weight limit 50lbs
7. 1 backpack (regular school size) 12 lbs max
8. 1 string bag for touring with umbrella and 3-ring-binder at all times

### Clothing & Shoe requirements

9. 1 long(er), heavier nylon puffer coat waterproofed with CampDry. One hiking pants or windbreaker pants.
10. 2 pair of good walking shoes/boots, comfortable to walk in all day waterproofed with CampDry (no Converse or other cloth made shoes)
11. NO USA logos visible on clothing. NO camouflage clothing or hats. No TORN clothing!
12. NO leggings or similar to be worn without a blouse or sweater covering behind to mid-thigh
13. Coats need to be worn/or on you every single day

### Other

13. When traveling north, lunch stops very likely will happen when and where it is convenient for the bus, group and timing. Lunches are paid individually (also to practice language skills). This might be at a fast-food-place. Here, you may choose what you like to eat. Restaurant dinners are group meals.
14. Bring a see-through reusable water bottle to have in your string bag when traveling. Sodas are very expensive.
15. Facebook/WhatsApp or Telegram account for parents and students is required for communication.
16. Do not bring/purchase weapons or look-alikes.
17. Attendance of afternoon classes is mandatory.
18. Parents and students must be in FB Group Exchange 2020 for communication
19. Students must bring a WIFI electronic device for *Mobile Pass* and Airline apps to be used at appropriate times.
20. Parent Volunteer Agreements needed

## Repeater Rules and Expectations

### Rules

1. We are one group and all activities will be obligatory for all. Please refrain from negative comments such as "I have already seen this" or "Do I have to go there again". Comments such as these will ruin the group spirit and causes friction among group members.
2. Do not kill the "Awe" factor for others by giving away too much (often negative) information.
3. Each year is different and should/cannot be compared. Never say "...but last year..."
4. Be helpful to "newbies" without being "bossy" about it.

Negative comments will be corrected; parents will be contacted; repeated comments might result in a failing grade.

### Expectations

5. Repeaters are role models for others. They will aide with chores such as
  - a. Head count of group
  - b. Help reminding everyone whose turn it is for photo book, bus clean-up etc.
  - c. Monitor themselves and others to do assignments and journal entries diligently and punctually
  - d. Making sure American students mingle with Italian students (school, bus, activities, waiting in morning for classes to start, dinners etc.)
